## **FINANCIAL REPORTING**

Mr. Addison provided a brief overview of the school's financial health. Currently, 87 students are enrolled and thanks to a 97% Average Daily Attendance rate for the school, the forecasted net income will be \$163,000 by June 30th. At the next board meeting in May a draft budget for the upcoming school year will be shared.

## **EXECUTIVE DIRECTOR REPORT**

Mr. Gomez provided the following executive summary.

- **Student Enrollment** - Plans are underway to enlist a recruiter so that the school opens next fall with 187 students. An interest list has been created for entering 6th and 7th graders. BPA will also participate in community recruiting events including door knocking to enroll students for the next school year.
- **Training** - Board members need to participate in brown act training which will be conducted by Procorpio before the school year ends.
- **Facilities** - The site previously identified is no longer an option since the current tenet bought it. As a possible solution, a prop 39 application will be submitted to Compton Unified School District. This will require Compton to provide a facility for BPA even if it's not in an ideal location.
- **NWEA Testing** - BPA students have demonstrated positive learning gains as reflected in the latest round of NWEA testing. 85% of students' scores have increased, particularly in Math and in English Language Arts. These gains are due to the support provided by the Instructional Aides along with after school tutoring. Students are being acknowledged for all their hard work through Friday pizza parties, certificates of achievement including gift certificates to Starbucks.
- **Updates** - the teachers are benefiting from several educational tools which have also led to increases in student test scores such as BrainPop, I-XL, Moby Max, Edulastic (which helps teachers develop assessments). The school is planning for the first graduation next year. Soon CCSA plans to visit BPA and they will bring the media to showcase BPA's success. Mr. Gomez presented at the CCSA conference in March (in Long Beach) and invited board members to participate next year when the conference is in Sacramento.
